Subject: Quality control of experimental mRNA SARS-CoV-2 vaccine injections

Dear Sirs/Madames

For more than two years, the doctors and researchers of the campaign *Let's Save the Children of Finland* have been trying to enter into a dialogue with you and the Finnish Medical officials about the experimental mRNA-SARS-CoV-2 injections that have been given to approximately 70% of the people of Europe in response to the declared state of emergency.

The injections not only have been insufficiently researched but by now they have been proven to be harmful and ineffective. Moreover, invasive procedures have been used without written informed consent in violation of the Nuremberg Code. Throughout this unprecedented experiment on the European population, your agency has repeatedly taken recourse to political jargon to escape responsibility.

We insist on getting scientific explanation on the following:

- 1. What are the sharp geometric structures, ribbon-like and tubular structures, crystal formation, microspheres and possibly self-assembling objects reported in 26 studies from 16 different countries from 5 continents? The results are summarized in a 130-page article (<u>Hughes DA 2022 What is in the so-called COVID-19 "Vaccines"? Part 1: Evidence of a Global Crime Against Humanity.</u> JJVTPR 2(2):455-586.
- 2. Why does the blood of the "vaccinees" show serious signs of degradation, why do the red cells lose their shape and accumulate in so-called Rouleaux formation? Such a phenomenon is found in the blood of chronically ill patients, such as patients with HIV and advanced cancer.
- 3. Why have many researchers found the presence of heavy and rare metals in the content of the vials? What do these ingredients have to do with the vaccination? (Summarized in <u>Hughes DA 2022 What is in the so-calledCOVID-19 "Vaccines"? Part 1: Evidence of a Global Crime Against Humanity. IJVTPR 2(2):455-586).</u>

4. Do you have scientific reports showing that you did perform the quality control of the batches used in Europe? We want to see your reports, including the names and affiliations of the researchers, the materials and methods that were used, and the results and conclusions.

We will not accept your reference to the quality control of manufactures alone or your flow charts or reference to some links. We want to see the real QC report. Your function should be transparent. Your mission is to secure the health of the people of Europe.

In the event that you are of the opinion that all the findings made by the researchers of the 26 groups are wrong or that all of them used wrong methods, we request that you justify your position in a scientifically sound way.

To reliably clarify this issue that is extremely important for the nations of the European union, we propose that an **Independent European Study Group** be established to examine the contents of the vials of the mRNA-SARS-CoV-2 injections. We demand that institutions conduct their research on the basis of accepted scientific approaches free of any collaboration or other conflict of interest with Big Pharma.

This letter is being sent to the Members of the European Parliament and widely distributed in social media. We will do our utmost to discover the truth: what are the objects described, what is the purpose of their presence, what is their function in the body, and how do they interact with the human organism.
