Dear Sir/Madam,

Thank you for responding (October 21st 2022) to our questions about the contents of the injectables mandated for Europeans during the COVID-19 pandemic and for your role in supervising their quality.

Your response is an expression of opinion. We do not want opinions but the facts.

In short:

1. You criticize the International Journal of Vaccine Theory, Practice, and Research.
2. You refer to the findings of Professor Pablo Campra and other 26 studies from 16 countries from 5 continents as "*known anti-vaxx misinformation*".
3. You criticize the methodology of Professor Pablo Campra.
4. You try to assure that you perform the quality control according to your specifications.
5. You deny that there is an effect on the human blood, especially in the form and stacking of erythrocytes upon the use of the injectables.

However

1. You do not provide us with a copy of any of your reports, especially the description of your materials and methods used to check the quality of each batch.
2. You do not show why there is such a big variation in the quality of the injectables <http://howbadismybatch.com>
3. You do present a single report from independent sources answering the need to show that the Covid -vaccination benefits outweigh the risks.

We would like to emphasize that further research since our latest correspondence shows that these matters need to be carefully addressed. <https://video.icic-net.com/w/d45c3f4a-7e9b-4478-be6f-820269343c85>

The researchers are from the USA, Australia, and Israel. The researchers present the same findings as in the paper by David Hughes that we cited in our previous letter. As a further case in point, we would like to cite the study from Germany https://www.theepochtimes.com/health/peeking-inside-the-covid-vaccine_4881567.html

We would also like to emphasize that we are not making any claims. We are only addressing questions to you as our European officials. We would like you to tell us the facts, not give us your opinions.

We want you to answer our two questions:

1. **What are the structures the researchers have documented independently of each other?**
2. **What is their role in these injectables?**

In answering these two questions, please give us your **actual reports**, including the microscopy and spectrometry on the quality assurance of the injectables with a specification of the batches. Theoretical descriptions of the processes do not satisfy our request.

We would also like you to answer this final question: **why did you not study the content of the vials together with the scientists who already undertook this mission?** An internationally performed well-designed study would certainly resolve the mystery of what ingredients are inside these vials. Such a study would leave no room for anti-vax misinformation.
